Bailey Landfill Asbestos Waste Documentation Requirements

Do I need to register as a Hazardous Waste Generator?

You will need to register as a Generator if you are disposing of more than 1,000 kg of asbestos waste in a single load, or are bringing in more than 1,000 kg of asbestos waste to the landfill within 30 days. It is free to register, and typically takes around 1-5 business days to obtain a number after registering. Please visit <http://www2.gov.bc.ca/gov/content/environment/waste-management/hazardous-waste/registration-of-hazardous-waste-generators-and-facilities> to obtain a Generator Registration (BCG) number.

Do I need a Hazardous Waste Transport Licence?

A transport licence is **not** required if you are a home owner or farmer taking your own asbestos waste from your home or farm directly to the landfill for disposal.

Do I need a Hazardous Waste Transport Manifest?

A Manifest is **not** required if you are a home owner or farmer taking your own asbestos waste from your home or farm directly to the landfill for disposal.

Do I need any other documentation?

You will need to provide your driver's licence so the landfill staff can document your address, and you will have to submit a "Drywall/Asbestos Waste Declaration and Acknowledgment Form" to the landfill staff. Copies of the form are available at the landfill, or can be picked up at the City Hall Engineering Reception Desk. It is recommended that you pick up the form at City Hall and fill it out before going to the landfill to save time. An example form can be viewed at www.chilliwack.com/landfill.

Is there a limit on the number of bags I can bring to the landfill?

The limit is 20 bags per originating property per day, up to a maximum of 100 bags per originating property per calendar year. The asbestos waste must be appropriately double-bagged in minimum 0.15 mm or 6 mil poly hazardous waste bags (maximum bag size is 38" x 60"), gooseneck-tied, sealed with duct-tape and labeled "Asbestos". You will have to lift the bags into a bin, so be aware of the weight of each bag. Do I need to register as a Hazardous Waste Generator?

You will need to register as a Generator if you are disposing of more than 1,000 kg of asbestos waste in a single load, or are bringing in more than 1,000 kg of asbestos waste to the landfill within 30 days. The Generator is the property owner, not the contractor. It is free to register, and typically takes around 1-5 business days to obtain a number after registering. Please visit <http://www2.gov.bc.ca/gov/content/environment/waste-management/hazardous-waste/registration-of-hazardous-waste-generators-and-facilities> to obtain a Generator Registration (BCG) number.

Do I need a Hazardous Waste Transport Licence?

A transport licence is required by all contractors bringing in asbestos waste that has not originated from their own residential property. If you wish to obtain a Hazardous Waste Transport Licence (LT), you must complete the Licence to Transport Hazardous Waste application package and test. Please visit <http://www2.gov.bc.ca/gov/content/environment/waste-management/hazardous-waste/transporting-hazardous-waste> to obtain a Hazardous Waste LT number. It typically takes around 4-6 weeks to obtain a licence after submitting an application.

Do I need a Hazardous Waste Transport Manifest?

A Manifest is required by all contractors bringing in asbestos waste that has not originated from their own residential property. The Bailey Landfill Registration Number (RS-108445) must be filled in the appropriate box of Part A. A single Manifest can be purchased from the Chilliwack FrontCounter BC office at 46360 Airport Rd. They can also be purchased in bulk. Do I need any other documentation?

You will have to submit a "Drywall/Asbestos Waste Declaration and Acknowledgment Form" to the landfill staff. Copies of the form are available at the landfill, or can be picked up at the City Hall Engineering Reception Desk. It is recommended that you pick up the form at City Hall and fill it out before going to the landfill to save time. An example form can be viewed at www.chilliwack.com/landfill.

Is there a limit on the number of bags I can bring to the landfill?
