Bylaw No. 2554

A bylaw to establish Development Fees

The Council of the *City* of Chilliwack in open meeting assembled enacts as follows:

1. This bylaw may be cited as "**Development Application Fee Bylaw 1998, No. 2554**".
2. "Development Fee Schedule Bylaw 1992, No. 1673" and amendments thereto, are hereby repealed.
3. Upon receipt of an application for development purposes required under any of the *City* of Chilliwack bylaws, the fees as set out in Schedule "A" attached hereto shall apply.
