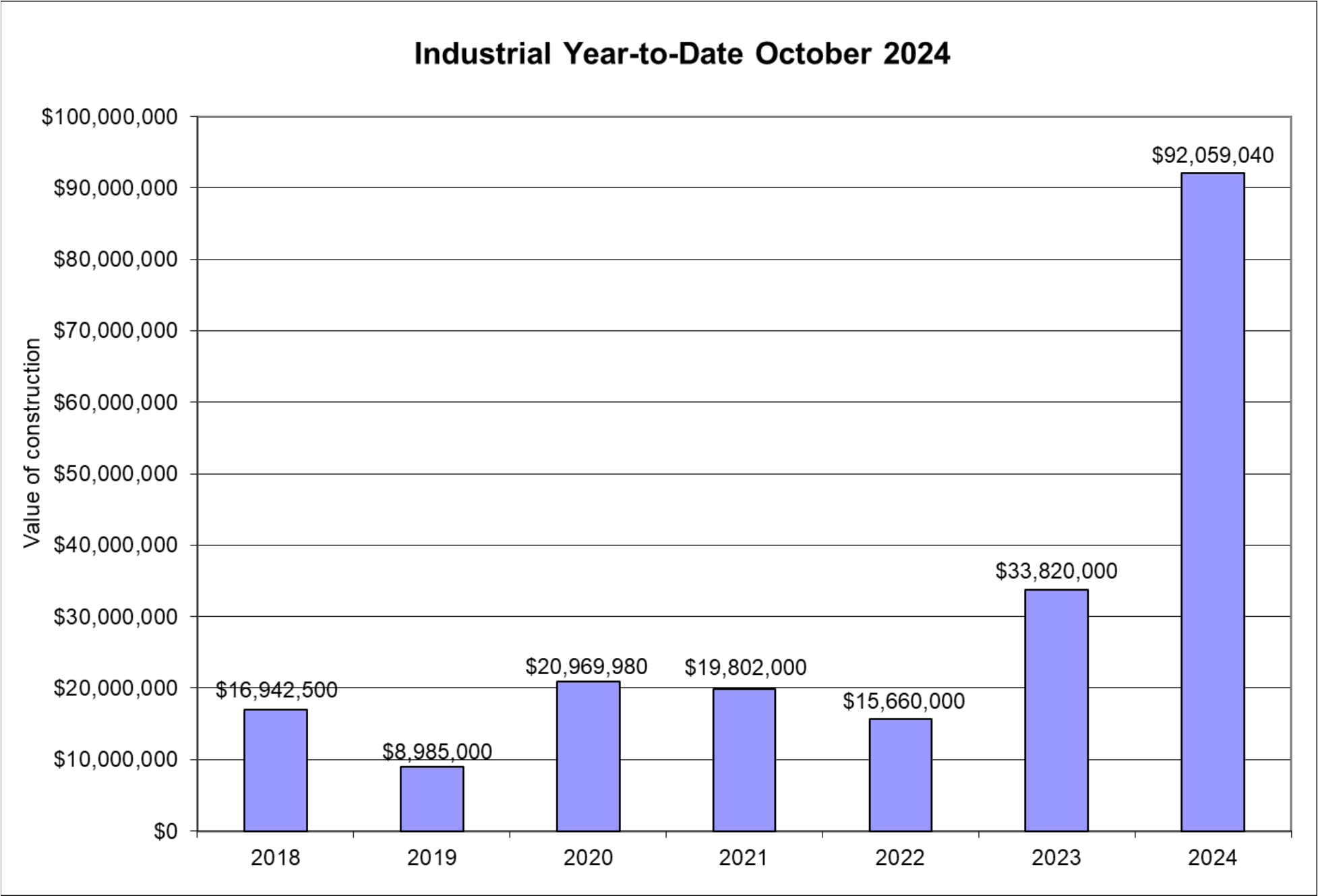
Year-to-Date 2024
