

## City of Chilliwack Leisure Access Program Application (2024)

The City of Chilliwack's Leisure Access Program (LAP) is administered by the managing operators of the leisure and community centres of the City of Chilliwack. The program provides Chilliwack residents with the opportunity to participate in the Recreation & Culture activities at very low or no costs. Client confidentiality will be maintained. Please note the requirements and terms of the Leisure Access Program are subject to change.

To <u>qualify</u> for this program, you must be a resident of Chilliwack and fall into **one** of the following categories:

- 1. Low income or on income assistance through the Ministry of Social Development and Poverty Reduction Program and Federal Employment and Social Development (see chart for low income qualifications).
- 2. Have a signed letter from Chilliwack Society for Community Living, Chilliwack Opportunity Society, Pacific Pathways OR verification of a disability (such as the Notice of Disability).

Please bring the application and the following original documentation to any Leisure Centre, Chilliwack Landing Leisure centre or the Cheam Leisure Centre:

- 1. Income verification -Line 150 of prior years tax assessment. (Must be government issued Notice of Assessment)
- 2. Confirmation of local residency (a copy of a utility bill and a copy of a rental/lease agreement). Please note the expiration of the Leisure Access Pass will align with the expiration of verification of residency. i.e. If your rental agreement expires on the first of the proceeding month then your LAP will expire at that time. Re-verification of residency is encouraged to be provided before expiry when ever possible.
- 3. Two pieces of ID (one of which is a photo ID) for the Main Household Contact and a Birth Certificate or Care Card for anyone under the age of 18yrs
- 4. A recent Letter of Disability (if applicable)

Applicants will receive access to the Chilliwack Leisure Access Program if their Total Annual Gross Income falls below the following limits:

For incomes greater than the above thresholds, LAP discounts will be based on the following criteria:

\$1 - \$500 is a 75% discount \$501 - \$1,000 is a 50% discount

\$1,001 - \$1,500 is a 25% discount

\$1,501 - \$2,000 is a 10% discount

\$2.001 and above - No discount

The City of Chilliwack Leisure Access Program reserves the right to refuse access to this program to anyone who provides false information on this application and any passes awarded will be terminated.
