TAKE NOTICE that the Council of the City of Chilliwack will hold a Public Hearing, as noted above, on the following items:

- 1. OFFICIAL COMMUNITY PLAN BYLAW 2019, No. 4767 (RZ001329)
- 2. ZONING BYLAW AMENDMENT BYLAW 2019, No. 4768 (RZ001329)
- 3. DEVELOPMENT VARIANCE PERMIT (DVP01074)

Location:46031 Airport RoadApplicant:Tariq WaheedPurposes:To amend the 2040 Official Community Plan designation, for the subject
property, from "Commercial Thoroughfare to "Medium Density Residential"
and to rezone the property from a R1-A (One Samily Residential) Zone to an
R5 (Medium Density Multi-Family Residential) Zone, as shown on the map
below, to facilitate the development of the partment complex.

The following variances are being equested to facilitate the proposed development:

- to reduce the front entrane (FLL) setback from 6m to 2m in order to accommonate the development and the 2.6m supplemental setback required for eture bad widening. As a result, the total proposed front yard setback induction will be from 8.6m (6m FLL + 2.6m of supplemental) to 4.2m (20.5m) + 2.6m of supplemental);
- to reduce the required number of off-street parking spaces from 1.5 spaces or unit to 1 space per unit (i.e. a total of 20 spaces to 13 spaces); and, o reduce the required number of visitor parking spaces from 1 space per 5 units to 1 space per 7 units (i.e. a total of 3 spaces to 2 spaces).



Persons who deem that their interest in the property is affected by the proposed amendment bylaws and permit will have an opportunity to be heard at the Public Hearing or, if you are unable to attend, you may provide a written submission, **including your full name and address**, to the Corporate Services Department at 8550 Young Road, Chilliwack, BC, V2P 8A4 or by email to <u>clerks@chilliwack.com</u> no later than <u>4:00 pm on the date of the Public Hearing</u>. All submissions will be recorded and form part of the official record of the Hearing.

These proposed bylaws and permit may be inspected between the hours of 8:30 am and 4:30 pm, Monday through Friday, excluding holidays, from **Wednesday, January 8, 2020 to Tuesday, January 21, 2020,** both inclusive, in the Corporate Services Department at City Hall, 8550 Young Road, Chilliwack, BC.
