Locations: 46074 and 46080 Princess Avenue


Applicant: City of Chilliwack

Purposes: To amend the 2040 Official Community Plan designation for the subject

properties, as shown on the map be v, from 'Resiductial 1 (Downtown Single Family)' to "Institutional and Civic be" and rezone the properties from an R2 (Urban Residential Tradition) Zone to Properties Parking) Zone,

to facilitate the construction of parking lot.
