TAKE NOTICE that the Council of the City of Chilliwack will hold a Public Information Meeting, as noted above, on the following item:

1. DEVELOPMENT VARIANCE PERMIT (DVP01199)

Location: 7990 Lickman Road


Applicant: Mainland Developments (Lickman) Ltd .

Purpose: The applicant requests multiple variances to facilitate construction of a mixed commercial and

industrial development, on the subject property, as shown on the map below. The variances are as follows:

- Waive the requirement to increase the width of a pedestrian pathway by 0.6m where adjacent to the loading bays in front of Buildings 3 and 4;
- To allow the 162 parking spaces provided on the property to be sufficient for all uses on site regardless of future tenants or possible tenant improvements which result in additional floor area;
- Permit the drive-in aisle associated with the drive-through establishment to be located between the building and front lot line;
 - Waive the requirement for the customer access to a drive-through establishment to be clearly visible from the public street;
- Waive the requirement for a drive-in aisle to be located between the building and rear lot line on properties located on minor arterial roads; and,
- Increase the maximum copy area for business premise signs within 600m of Highway No. 1 from $20m^2$ to $26m^2$.
