TAKE NOTICE that the Council of the City of Chilliwack will hold a Public Hearing, as noted above, on the following items:

- 1. OFFICIAL COMMUNITY PLAN BYLAW AMENDMENT BYLAW 2021, No. 5054 (RZ001394)
- 2. ZONING BYLAW AMENDMENT BYLAW 2021, No. 5055 (RZ001394)
- 3. DEVELOPMENT VARIANCE PERMIT (DVP01172)
 - Locations:9374 and 9388 Ashwell RoadApplicant:OTG Developments Ltd.Purpose:To amend the 2040 Official Community Plan designation for the subject
properties, as shown on the map below, within the Chilliwack Proper and
Fairfield Island Neighbourhoods Plan from "Residential 1 One and Two Family
Housing" to "Residential 2 Attached Housing and Narrow Lot Infill" and to
rezone the properties from an R1-A (Urban Residential) Zone to an R4 (Low
Density Multi-Unit Residential) Zone to facilitate the construction of a 7-unit
townhouse complex. A Development Variance Permit application was also
submitted to run concurrently with the rezoning which seeks approval to reduce
the minimum front lot line setback of the proposed R4 Zone from 6m to 3m.
