- 3. DEVELOPMENT VARIANCE PERMIT (DVP01132)

Applicant:	Fraser Valley Regional Hospital District
Purposes:	To amend the subject property's 2040 Official Community Plan
	designation from "Thoroughfare Commercial" to "Institutional and Civic Use" and to rezone the property, as shown on the map below, from an
	AP (Airport Commercial) Zone to a P2 (Special Institutional) Zone to facilitate the development of a new senior's residential care facility.

Additionally, an application to increase the maximum height within the P2 (Special Institutional) Zone from 15m to 24m to facilitate the development of a new long-term senior's residential care facility is being considered concurrently with the rezoning application.
