



Locations:46019 and 46029 Southlands DriveApplicant:City of ChilliwackPurpose:To amend the 2040 Official Community Plan designation for the subject
properties, as shown on the map below, from "Low Density Residential" to
"Institutional and Civic Use" and to rezone the properties from an
R1-A (Urban Residential) Zone to a CP (Commercial Parking) Zone, to
facilitate construction of a parking lot associated with City Hall at
8550 Young Road.

 - a. Be prepared to provide the public hearing number you would like to speak on along with your full name and address
 - You will be allowed to present <u>once</u> for each public hearing and be given up to 15 minutes to make your presentation

These proposed bylaws will be provided via email upon request between the hours of 8:30 am and 4:30 pm, Monday through Friday, excluding holidays, from **Wednesday**, April 21, 2021 to Tuesday, May 4, 2021, both inclusive, by the Corporate Services Department.
