TAKE NOTICE that the Council of the City of Chilliwack will hold a Public Hearing, as noted above, on the following items:

- 1. OFFICIAL COMMUNITY PLAN BYLAW AMENDMENT BYLAW 2021, No. 5094 (RZ001484)
- 2. ZONING BYLAW AMENDMENT BYLAW 2021, No. 5095 (RZ001484)
- 3. DEVELOPMENT VARIANCE PERMIT (DVP01184)

Locations: 45825, 45835, 45845, 45855 Rowat Avenue and 45865 Trethewey Avenue

Applicant: Nomodic Modular Structures Inc.


Purposes: To amend the 2040 Official Community Plan designation of the subject properties, as shown on the map below, from "General Industrial" to "Comprehensive Development

Area" and rezone the properties from an M1 (Light Industrial) Zone to an R8 (Supportive Housing) Zone to facilitate construction of a BC Housing funded supportive housing and shelter development. An application to vary the following standards of the proposed R8 Zone is being considered consurrently with the recenting application:

Zone is being considered concurrently with the rezoning application:

- Increase the maximum building height from 15m to 17m; and,
- Waive the berming/screening requirement for properties adjacent to a railroad in favour of the use of a 3.3m tall acoustic concrete panel fence.

 - b. You will be allowed to present <u>once</u> for each public hearing and be given up to 15 minutes to make your presentation
