TAKE NOTICE that the Council of the City of Chilliwack will hold a Public Hearing, as noted above, on the following items:

## 1. ZONING BYLAW AMENDMENT BYLAW 2021, No. 5139 (RZ001538)

**Location:** 8550 Young Road

**Applicant:** City of Chilliwack

**Purpose:** To amend the text of the Zoning Bylaw to include Short-Term Rental as a permitted

Accessory Home Occupation type. In addition, a new definition of Short-Term Rental and Principal Residence is proposed, including updates to existing definitions for Boarding, Boarding House, Dwelling Unit, Family, and Tourist Accommodation, as well as incorporating new terminology to replace "Bed and Breakfast" with "Short-

Term Rental" to ensure consistency throughout the Zoning Bylaw.

As a result of public health considerations, it is strongly recommended that the public take advantage of the opportunity to participate in the Public Hearing process remotely via Zoom, although in person participation at the HUB International Theatre is permitted at this time.
